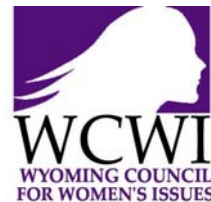

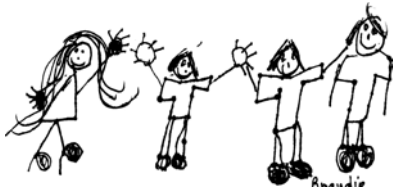

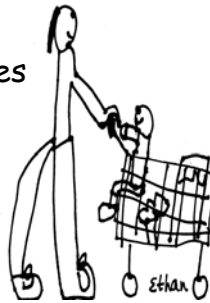
Preface

residents. **Inclusion is not an endorsement by the Wyoming Council for Women's Issues.**

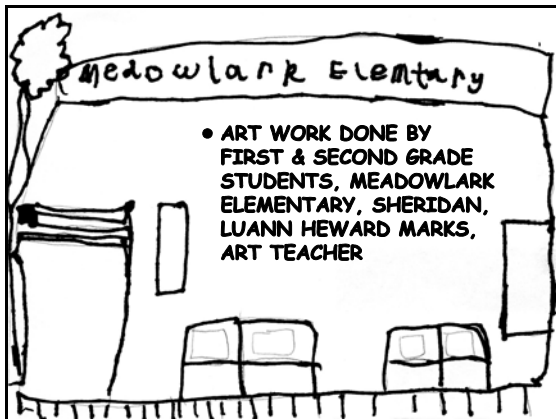
A private organization has been included if it meets a human service need for which there has been a demonstrated need not generally met by public or non-profit organizations.
